Old Business (Review of the minutes of previous meetings)</p>	<p>American Haflinger Fund—there will be a AHFund Board conference call to discuss the current status of the 501 (c) 3 corporation.</p> <p>HBO/AHR merger progress was discussed. HBO papers continue to be transferred to AHR papers as the requests come in.</p>
<p>II. Office Update – Ruth Schwab</p>	<p>The installation of a replacement computer server and 3 replacement PC workstations is complete. The new equipment is working well and is a HUGE improvement in capability and speed. We continue at a frenzied pace with the last minute foal rush. Today's pile of mail was measured at 15 inches. For the month of December (minus holiday and vacation days), QuickBooks shows the line item transaction count at 4,594. Foal registrations completed this month are 73 and transfers completed are 267. Year-to-Date we have completed 953 foal registrations and 4,109 transfers. We are expecting an additional 700 to 800 foal applications will be received by fiscal year end. (Remember, these numbers don't include the registrations and transfers that we have worked on, but were unable to complete.) Stallion license renewals paid year to date are 405. Members already renewed for 2007 = 500.</p>
