	The January 7, 2009, meeting was called to order by President Bill Jameson at 8:07 p.m. (EST). I. Old Business (Review of the minutes of previous meetings)	
II. Office Update – Ruth Schwab	For the month of December, Tana has processed 4473 line items through QuickBooks. Sheila reports that the Pedigree department has processed 77 foal registrations and 272 transfers while continuing to work on problem files and file cleanup. We have completed the last three pedigrees submitted in 2008 for imported horses. Stallion license renewals received for the 2009 breeding season thus far are 292. There are currently 144 magazine subscribers. 2008 members to date are 1,638. We are not quite halfway through the mail dated received 12/31/08 so there will be some additional memberships entered for those people who waited until the last minute to register foals and renew their membership in order to get reduced rates. 81 new members took advantage of the pro-rated membership offer for 2008/2009. There are 508 2009 members logged in thus far. The membership renewal application will be included with the Feb/March issue.

	fall of 2009 and hopefully it will be a little better supported. The spring sale will be
	held May 22 & 23, 2009. The consignment packet will be included as an insert with
	the Feb/March issue of the magazine. The D&T committee has requested that they
	be allowed to run a testing in conjunction with the fall sale. The price will be
	reduced for horses that run through the testing and are also consigned to the sale.
