OLD BUSINESS & COMMITTEE REPORTS

Office Relocation (Ad Hoc) Committee

Futurity & Stallion Showcase Committee

Mary Procopio shared the following information on 12/18/16 regarding our request for more info on the 3 year old class: Four of the five members of the committee have voted to cancel the three-year-old classes due to low enrollment. (I haven't heard back from the fifth person yet.) At least two of us would have had three year olds eligible and were in favor of this decision. As three year olds are breeding stock animals, going with just the weanlings through the two-year-olds enables us to put more money into the payouts for those classes, as well as focus on the young horses.

Dave Ayers moved to cancel the 3 yr old classes based on low enrollment. Ian Wengerd seconded. Motion carried unanimously.

Sale Committee

DV Auction has agreed to an expense cap. Deposit is \$1250 (Committee has donors if sale profits can't cover this.) and need board approval to be paid. Ian Wengerd moved to authorize the deposit payment. Missy Shanahan seconded. Motion carried unanimously.

Appendix 2

National Show Committee Report

The Show Committee has continued to work well and hard together this past month, with the following noted accomplishments:

The signed contract and \$5,000 sponsorship deposit was sent to and received by the Kentucky Horse Park, securing the Alltech

Arena and Barns #22, 23 & 24 for the AHR National Sport Horse Show, July 5-8, 2018. (Early/late arrival/departure is available at a cost of \$50/stall per night,

payable by the exhibitor, if stalls are available, and only if pre-arranged with KHP. Early arrival is considered to be between noon July 2 and 8:00 am July 4. Late departure is after 8:00 am July 9.)

A signed copy of the contract is on file with AHR President, Chuck Hendershot.

Confirmation of available space in the upper level of the Alltech Arena of approximately 40 (10 x 10) vendor space areas to be rented to vendors attending the AHR National Sport Horse Show Trade Fair running concurrently with the National Show. Costs to vendors range from \$250 to \$1,000, depending on the type of vendor (AHR member/non-profit; small business; large business) with major sponsors (donating \$2,500 to \$10,000) receiving a free vendor space as part of their sponsorship package. Cost to AHR is \$100 for each 10 x 10 space rented out to a vendor, payable within 30 days after the show. Our goal is to secure a full slate of vendors offering products in a variety of price ranges, helping to offset the overall cost of the venue.

The following (and first) Facebook announcement was posted December 29, 2016:

With another dressage show scheduled at KHP the same weekend, we have received much interest from Haflinger owners planning to attend both shows, so have added dressage classes.

A www.haflingernationals.com domain has been purchased and donated by Jessica Hanney, together with 2 years of hosting. Jessica is working on developing the website which will link to the AHR site and Facebook page, plus offer visitors the ability to donate as a sponsor of the show or to their own show account.

To generate a cleaner line of communication, four, free email addresses have been secured to serve our exhibitors (entries@haflingernationals.com), advertisers (advertising@haflingernationals.com), sponsors (sponsors@haflingernationals.com) and vendors (vendors@haflingernationals.com).

Forty (40) hotel rooms have been reserved, with no financial obligation, at the Fairfield Inn & Suites/North Lexington, the closest hotel to the Kentucky Horse Park, for July 2 thru July 9. A reduced rate of \$95/night room rate and \$35/stay pet fee (vs. \$75) has been negotiated and in the process of being contracted now. Guests must mention AHR NATIONAL SHOW and provide their own credit card when booking. One additional hotel will be blocked off later.

Twenty (20) campsites have been reserved at KHP, with campers reserving and paying for their own sites. Water and electric is available. No sewer. Must mention AHR NATIONAL SHOW when reserving.

Golf cart rentals have been researched, with Dever's being KHP's main source for on-ground transports (gators, golf carts or

bicycles recommended). https://www.deverinc.com/ (Note:

There is a \$15/week or \$5/day parking fee for everyone entering KHP.)

Review of the current AHR rules begun.

Review, discussion, and development of a revised class list near completion.

Development of sponsorship tiers, benefits, and communications (Major Sponsor draft enclosed)

Review and beginning preparation of potential major sponsor and vendor lists

Initial consideration of photographers and announcers researched

Volunteer opportunities created at no cost on Signup.com where potential volunteers can see how and when help is needed. The site allows volunteers to view and sign up online for a particular task on a particular day and time. The site currently offers specific volunteer opportunities through Friday of the show, with additional volunteer opportunities being added for Saturday, Sunday, and more later.

Inquiries into Churchill Downs (for a donation of Kentucky Derby tickets) and trailer dealership (for trailer) to be used as raffle items.

Live streaming options being explored (iequine)

Beginning inquiry into organizing a breed versatility demonstration in the Visitor's Center arena.

Development of three "Grand Finale" events to end each of the following evenings:

o Thursday – Barrel Racing to Benefit Cancer Treatment Centers of America

o Friday – Exhibitor's Party and Driving Derby

o Saturday - Jackpot Versatility

MOVING FORWARD, we plan to focus on the following in the coming month:

Finalize sponsorship, vendor, and advertising packets and get them in the hands of potential sponsors/vendors/advertisers.

Finalize class list

Communicate with the AHR Spring Sale Committee and develop advertising for the AHR National

Sport Horse Show Tack Sale

Secure major sponsors

Secure major raffle donations

Continue review and finalization of show rules

Finalize budget

Secure a time for KHP Breed Versatility Demo

Continue to add volunteer opportunities on SignUp.com

MOST IMPORTANTLY is the subject of judges. It is critical to the success of the show that qualified judges in their respective disciplines are secured for the show. Together, the Committee has compiled and enclosed a list of judges for your review. Additionally, the following information and request was received from the 2016 National Show Committee for your consideration:

There have been concerns raised to the committee from AHR members about judging bias and conflict of interests with using AHR approved judges and with the past 2016 AHR National Show.

We understand that the 2016 AHR National Show judge was NOT an AHR approved judge but she was hired by the eventual winner of the BOS award for the halter division. There have also been many voiced concerns about AHR judges scoring/judging based on pedigree and owners. The

committee is concerned that if an AHR approved judge is hired for the 2018 show and one of the horses they bred or one of their friends wins, even if deserved, it would be construed as a conflict of interest. The committee feels to keep an even playing field for all and to promote good will during this transitional time for our breed it would be in the best interest for all to choose a highly qualified USEF in hand sport horse judge to judge the halter portion of the 2018 National Show.

Our current Committee would like your approval on this request as we would like to contract all judges no later than March 1,

Appendix 3

Pedigree Committee Report

Effective 01/01/17, in order to register foals with the American Haflinger Registry (AHR) all

- (1) completed paperwork,
- (2) hair samples,
- (3) breeding certificate,

- (4) foal registration form,
- (5) facial pictures, and
- (6) any other required submission

must be received by the AHR registrar on or before the deadline of December 31 or the late fee will be incurred. The DNA results can be pending when the deadline is reached but the hair samples and all correctly completed paperwork must be received by the registrar prior to the deadline in order to avoid the avoid the penalty.

Beginning 1/1/17, the pedigree committee will assist the registrar when issues arise regarding incomplete or inaccurate paperwork related to

- (1) registration,
- (2) transfer,
- (3) stallion licensing,
- (4) DNA results, and other situations concerning
- (5) maintenance of official registration papers of the AHR.

The procedure will be as follows: Upon realization of a problem, the registrar will notify the submitting member by:

- (1) a short phone call / voice mail stating the problem and necessary action, or
- (2) an email stating the problem and the necessary action.

If the member provides the needed information to the registrar the paperwork will be processed. If the registrar does not receive the missing information within 10 days of the initial member notification, the registrar will mail an information request form explaining the problem and asking the member make to the necessary revisions and return the corrected forms. The registrar will then wait two weeks for a response. All communication with the member in attempt to resolve the issue will be documented and

kept with the original submission. The fee will be deposited into the AHR account. If no response is received, the registrar will then pass the issue on to the pedigree committee to be resolved on a case by case basis. If a solution cannot be reach by the registrar or the pedigree committee, fees and forms will be returned to the member. No updated certificates or registration papers will be issued if paper work is not complete and correct. No updated certificates or registration papers will be issued to a member without proper and complete payment.

Certified pedigrees will be mailed to the owner in a clear plastic binder sheath to protect the document and discourage owners from punching holes in the official pedigree.

An official stamp will be used to mark pedigrees of horses that have been gelded provided that the certified pedigree along with a gelding certificate is received by the registrar proving that castration has been completed.

Amnesty Program Rules and Requirements:

- 1. The Amnesty program is available to AHR members only.
- 2. All fees for registration and transfer apply to Amnesty program horses.
- 3. All horses must be DNA tested to be eligible for this program.
- 4. In cases where the stallion was not licensed for the year of conception, the renewal fee must be paid in order to have the registration processed.
- 5. A \$35.00 late registration fee will be applied.
